Who We Are

Wherever there is poverty and people in need, you will find a Society of St. Vincent de Paul there to serve them. Founded in 1833 in Paris, France by Fredric Ozanam and his companions, and placed under the patronage of St. Vincent de Paul, the Society strives to help those who are suffering and in need. We are a person-to-person ministry and see the face of Christ in those we serve.

How We Serve

The District Council of Fort Wayne consists of 22 "conferences", the basic units of the St. Vincent de Paul Society and typically established at a parish, representing 24 parishes in 7 Northeastern counties in Indiana, covering cities like Decatur, New Haven, Columbia City, Fort Wayne and many others. Several of our conferences operate food pantries providing assistance to qualified clients who struggle to pay their rent and utilities, much less put food on the table for their families.

The Society operates a Thrift Store in Fort Wayne. Clients can receive vouchers from a local conference, and redeem them at our store on items such as clothing, furniture, appliances, and household goods. This service is much appreciated by our clients, like Carla.

New to the area, Carla visited one of our local parish conferences for assistance. After determining her needs and eligibility, she left with a voucher for the Thrift Store which she redeemed for a couch, a table and a bed, as well as some clothing.

Our Care-Van service transports those with limited means, like Guadalupe, to and from their medical and rehabilitation appointments. St. Vincent de Paul transports Guadalupe to her residence three times a

week after her dialysis treatments. She is so grateful for our assistance, and Guadalupe is just one of the many clients we help every week.

Our Needs

The poor will be with us always. In addition to donations of clothing, furniture, household items, and even vehicles, financial assistance is our biggest need. Driven by our vision and passion for the mission of St. Vincent de Paul, both now and forever, we established the *Society of St. Vincent de Paul Fort Wayne Endowment Fund* within the Catholic Community Foundation of Northeast Indiana, permanently setting aside funds for the purpose of generating income for future needs. The principle monies can never be withdrawn from this endowment, and the investment income distributed every year to ensure a steady stream of financial assistance is always available to help those in need, even when we are gone.


